Pool House Remodel Update

The pool house remodel nears completion. The interior upgrades are nearly completed with new plumbing, electrical, floor and wall tile, new toilets, showers, and changing rooms. Work on exterior upgrades continue with a ramp, exterior showers, drinking fountain, and other improvements. Work is expected to be completed by Spring.

Coming this Spring... Pickleball

Work has begun on a pickleball court. Workers will be filling in gaps and cracks, resurfacing, and adding a layer to even it out. Finally, they will add lines for pickleball, badminton, and volleyball, and installan adjustable net.

Key Fobs to Access Clubhouse & Pool

Before the February 6th Annual Board meeting, we will be handing out the first of the key fobs that will provide access to the pool and clubhouse lawn including the sport court during scheduled times. Access to the facilities may be unsupervised at times so it is important the Association have rules in place that limit our community's liability. No unsupervised minors under the age of 18 may access the property using the key fobs. In order to get your key fob, you will need to sign the *Release of Liability and the Use of Facilities Terms and Conditions*. Only one fob per household. Information will be posted on Feb 1 on the website with directions how to sign up to get a fob on February 6th. More dates will be announced. Access to the facility will not begin until Spring 2024.

MIA Payment Plans

- 1. Pay your \$954 balance in full before 1/31/24
- 2. Split into 2 payments of \$477 each.
 Pay \$477 before 1/31/24 & pay another \$477 by 7/31/24
- 3. Make 4 Quarterly Payments of \$245 each - Pay \$245 (includes processing fee) by each of the following dates: 1/31/24, 4/30/24, 7/31/24, 10/31/24
- 4. Make 12 Monthly Payments of \$85 each - Pay \$85 (includes processing fee) by the end of each month in 2024

To avoid any late fees/charges, please ensure the appropriate payment is made on time.

MIA Swimming Pool Remodel

At the Feb 6th Meeting we will discuss the plans to replace the decking and replaster the pool. Unfortunately due to the urgency of needing repairs, the cost of work, and high interest rates, the board has determined that reshaping the pool cannot move forward. Replacing the deck and re-plastering is budgeted and will leave additional funds to make other improvements to the property. To hear more about the plan, join us Feb 6th.

The community will have an opportunity to review and offer input on the handbook before it adopted.
